4. Policy Submission Forms must list cases submitted during that calendar month for your state's promotion.
5. Agents may not assign, combine, or transfer business. Agents may not change agent-of-record or writing agent statuses with other agents for the purpose of earning contest credits.
6. Policies/certificates of an agent or members of his/her family do not qualify. Policies must be active at payout.
7. Internal replacements, rewritten cases and/or add-ons do not earn credit.
8. Credit for unique market agreements including list bill cases will be subject to Home Office approval.
9. The value of the promotion is taxable for qualifiers and reported on their annual IRS 1099 Form.
10. Only World Major Medical and HSA-Qualified plans qualify for credit. Short-term medical does not count.
11. Agents must be in good standing with World at the time of the award.
